Session Fees and Length of Service

Sessions will be fifty five minutes in length, but the initial session will be 110 minutes. Sessions fees will be based on fifty five minutes (except initial session) and based on a sliding fee scale. Payment for counseling services are due at the beginning of each session. For tele-therapy, you can pay directly on the online platform prior to beginning your session. You may pay debit or credit card, which you will set up. If you wish to file a claim with your insurance company, it is your responsibility to contact them and I will provide documentation at your request, which will require a diagnosis that becomes a part of your health record. The sliding fee scale is based on U.S.A. poverty guidelines and compares your family size and total income. The breakdown of fees is including weekly, bi-weekly, monthly, or annual income; however, you will need to provide proof of what you claim. You will need to provide two pay stubs while setting up services, and then annually thereafter. For no-show appointments and cancellations made in less than 24 hours, you will be charged for the appointment at full price.
